UNAUTHORIZED CIRCULATION OF OFFICIAL DOCUMENTS/INFORMATION ON SOCIAL MEDIA

The attention of the Office of the Head of the Civil Service of the Federation has been drawn to the incessant unauthorized disclosure of official documents/information on social media platforms. The unwholesome practice involves posting/reposting of secret, confidential and classified government correspondences, policy drafts, minutes, notes, memos, etc., on social media.

- 2. This reckless action is tantamount to a breach of the Oath of Secrecy public servants swore to, and a serious misconduct which may lead to dismissal from the Service, as provided in the Public Service Rules (PSR) 030401 and 030402.
- 3. Henceforth, any officer caught posting/reporting government documents on social media and other platforms without authorization would be <u>severely</u> disciplined in accordance with the provisions of the PSR.
- 4. This Circular, therefore, reinforces the earlier Circular on the subject, Ref. No/HCSF/109/S.1/120 dated 22nd May, 2020 and other extant regulations prohibiting unauthorized publishing of official documents.
- 5. Permanent Secretaries and Heads/Chief Executive Officers (CEOs) of Extra-Ministerial Departments are to bring the content of this Circular to all staff for compliance.
